The Archeparchy of Winnipeg makes available to you this mobile App subject to your acceptance of and compliance with these terms of use (the "Terms of Use"). BY ACCESSING, BROWSING, AND/OR USING THIS APP YOU ARE ACKNOWLEDGING THAT YOU HAVE READ AND UNDERSTOOD THESE TERMS OF USE AND OUR PRIVACY POLICY AND THAT YOU AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS. IF YOU CANNOT OR DO NOT AGREE WITH THESE TERMS OF USE OR OUR PRIVACY TERMS OF USE THEN DO NOT ACCESS OR USE THIS APP.

The Archeparchy of Winnipeg reserves the right, in its sole discretion, to update, revise, supplement, and modify these Terms of Use as well as to impose new or additional terms and conditions to these Terms of Use at any time. Tax receipts for those donations directed to the Archeparchy of Winnipeg are issued by The Ukrainian Catholic Episcopal Corporation of Manitoba. All efforts are made to honour all donors' wishes and instructions in disbursing their donation to the charity or charities of their choice. Donations made directly to parishes results in a tax receipt containing the name of the parish and the Registration Number of the individual parish.

The Archeparchy of Winnipeg App automatically directs the donated amount (minus its payment processing fee described below) to the parish or fund selected by the donor.
